

# Execution of Political Prisoners in Iran: A Clear Violation of Human Rights

This report documents the names, details, and photographs of political prisoners currently on death row in Iran's prisons, highlighting the ongoing enforcement of execution — the most severe and irreversible punishment — against individuals from diverse ethnic backgrounds, age groups, and walks of life, many of whom have been sentenced without the observance of fair trial standards. This systematic practice not only represents a blatant violation of human rights but also exposes Iranian society to the regime's repressive policies. By publishing this list, we aim to raise awareness and draw public attention to the urgent need to prevent these executions.

#### Distribution of Prisons and Conditions of Detention

Political prisoners facing capital punishment are detained across Iran in notoriously harsh facilities such as Evin, Qezel Hesar, Urmia, Vakilabad (Mashhad), and Sepidar (Ahvaz) prisons. These detention centers have been thoroughly documented by Iran HRM in its previous reports as sites of systemic abuse, including torture, coercive interrogations, denial of access to independent legal counsel, and inhumane living conditions. Such practices are in clear violation of Iran's obligations under international human rights law, including the absolute prohibition of torture and other cruel, inhuman, or degrading treatment or punishment, as well as the fundamental right to a fair trial and legal defense.

### **Ethnic and Religious Discrimination**

Political prisoners on death row in Iran come from diverse ethnic and religious backgrounds, including Kurds, Baluchis, Turkmens, Arabs, and Persians. The disproportionate targeting of minorities, particularly from Sistan and Baluchestan, Kurdistan, and Khuzestan provinces, where many face charges of *Baghi* (armed rebellion) or *moharebeh* (enmity against God), reveals a pattern of state-driven repression against ethnic and religious communities. Numerous individuals are sentenced solely for their civic engagement or ideological beliefs, violating the principles of non-discrimination enshrined in international human rights treaties to which Iran is a party, including the International Covenant on Civil and Political Rights (ICCPR).

#### Politically Motivated Charges and Unfair Trials

Political prisoners are frequently charged with vaguely defined and politically motivated offenses such as *moharebeh*, *Baghi*, *efsad fel-arz* (corruption on earth), espionage, or actions against national security. These charges are often leveled without credible evidence and adjudicated in proceedings lacking transparency and due process. Sentences are frequently imposed for mere association with opposition groups or alleged foreign contacts, in direct contravention of the rights to freedom of expression, association, and fair trial guaranteed under international law.

#### Women on Death Row

While men constitute the majority of political prisoners on death row, women are not exempt from the regime's brutal crackdown. Among those sentenced to death are Pakhshan Azizi, Sharifeh Mohammadi, and Varisheh Moradi condemned for their alleged involvement with opposition movements. Their cases



underscore the indiscriminate nature of Iran's repression, where women, like men, face persecution and the ultimate penalty for exercising their political beliefs and rights.

# Execution as a Tool of Political Suppression

The death penalty in Iran is systematically employed as an instrument of political repression, intended to silence dissent, intimidate society, and stifle movements advocating for freedom and human rights. This practice, conducted in violation of due process guarantees and the right to life, has been repeatedly condemned by United Nations bodies and international human rights organizations. Despite international outcry, Iran continues to deploy this irreversible punishment as a means of control.

Iran HRM emphasizes the urgent need for international and domestic efforts to halt this ongoing atrocity. The abolition of the death penalty, particularly in political cases, alongside strict adherence to international human rights standards, is essential to prevent further irreversible injustices.
